## **General Rules**

#### ADDRESS CHANGES

Change of address or phone number must be immediately filed with the Parks and Recreation Department office or its duly appointed representative. Failure to comply will result in this player becoming illegal.

#### ALCOHOLIC BEVERAGES

Alcoholic beverages are allowed at L. W. BAUMGARTNER PARK **ONLY**, **never** at **Delia Park** or any school diamond.

# Drinking is not allowed before, during or between the games in which you are participating. This includes split double-headers!!!

Any player guilty of this infraction will be subject to one of the following actions, depending on the circumstances:

- 1. Not permitted to play the upcoming game (if found prior to game)
- 2. Ejection from current game and Three Week Suspension
- 3. Expulsion from the league

#### APPEAL PLAY

Appeals must be made (1) before the next pitch legal or illegal or (2) before all infielders have left their normal positions (crossed the foul lines). In a live ball appeal, runners may advance with the risk of being tagged out. In a dead ball appeal runners may <u>NOT</u> advance.

#### <u>ASA</u>

All teams in the league will be registered with ASA automatically. Your registration fee is included in your entry fee.

#### AWARDS

Regular season and playoff champions will receive team and individual awards.

#### KICKING

We will be using a 3-2 count. In the event the second strike is a foul ball, the kicker will be awarded one additional strike. Any subsequent foul ball will constitute an out.

#### **CUT-OFF DATE FOR SIGNING NEW PLAYERS**

Deadline for adding players shall be 2<sup>nd</sup> week for all leagues

#### **Conduct and Suspensions**

Sterling Heights Parks and Recreation has a **ZERO TOLERANCE POLICY** that focuses on improper behavior and speech of players, coaches and spectators for all Leagues. Accordingly, players,

coaches, and the managers on and off the playing area, before, during or after league play, shall conduct themselves in an orderly and acceptable manner. Any player, manager, or coach striking, threatening, or verbally abusing an official, spectator, fellow teammate, member of the opposing team, or Department staff member, found guilty of inciting a disturbance or riot shall be suspended indefinitely from league play pending review by the Recreation Supervisor. Any spectator, player, coach or manager using profane language will be ejected. The penalty for players, coaches and managers will be a minimum one-game suspension.

Any player removed by "ejection" will be suspended from their next scheduled game (or more depending upon the nature of the infraction). Penalties shall apply whether the offense occurs before, during or after league play. Further infractions may result in lengthier penalties, up to and including removal from the league. Suspensions will carry-over to the following season if there are still games to be served. The player or players involved have the right to appeal the suspension in writing (within 10 calendar days). This appeal will then be reviewed by a Recreation Supervisor and a decision made at the earliest possible date. A current list of suspended players is on file at the Parks and Recreation office.

#### **COURTESY RUNNER**

There shall be 2 runners allowed per inning. This runner must be the last out or the least likely to bat that inning (in the event that there is not a "last out"). THERE ARE NO COURTESY RUNNERS FOR OTHER CIRCUMSTANCES.

**For Co-Ed** leagues, the courtesy runner must be of the same gender as the batter/runner that is being replaced.

#### DRESS CODE

No uniform dress code is in effect. However, players are expected to dress suitably. Shirts and shoes must be worn. Hats or visors may be worn forward or backward. Bandanas are permitted; however, players may be required to take the bandana off if it becomes a safety concern during the game.

#### **EQUIPMENT**

Metal spikes (including metal tipped cleats) are <u>NOT</u> legal in any of Sterling Heights' adult leagues. Any person found wearing metal spikes will be ejected from the current game and an out will be taken in the spot if no person is available to substitute. See also the section on ejections for further action.

The official game ball will be provided by the Sterling Heights Parks and Recreation Department. For league and championship play, we will use the Gopher 8 ½ inch Ultra Utility Ball. Ball could be one of a variety of colors.

#### EXTRA KICKER RULE

Please learn this rule as improper use will result in ejection of illegal player and manager. EACH TEAM MAY USE A MAXIMUM OF FOUR EXTRA KICKERS. Use of an extra kicker/kickers remains optional. Extra kickers may be added to the lineup at any time during the game without penalty if they are just arriving. Extra kickers cannot be present at the start of the game and decide to join while the game is in progress. This rule is for players that are running late to the field. Abuse of this rule as deemed so by the Recreation Department will be grounds for disciplinary action including withdrawing the rule. The extra kicker may become a defensive player. They may remain in the game but switch positions with a defensive player. Example: In starting lineup Jones is extra hitter. Smith is right fielder, Jones goes to right field and Smith becomes extra hitter.

If you begin the game using extra kickers (eleven or more players), and an injury does occur, you may finish the game penalty free with one less player. If a player is injured and cannot physically continue playing, his/her spot in the line-up will be skipped and will not constitute an out. The extra kicker may appear anywhere in the line-up, so if he/she does replace a defensive player and you finish with ten, your line-up would be the same with the injured player deleted and no extra kicker. In the event that two or more people must leave the game due to injury, ejection, or any other circumstance, the player's team will have to forfeit the game and a win will be awarded to the opposing team.

**For Co-Ed**, this may be done as long as a 1 male to 1 female ratio is maintained. Example: Team A begins a game with 14 kickers, 7 females and 7 males. During the game, kicker 8, a female, cannot continue and is removed from the line-up. The manager must also remove batter 7 or 9, a male, in order to maintain the alternating kickers order. Because of this, managers must use extreme caution in the placement of their extra kickers.

#### **FORFEITS**

A team must have a minimum of 8 players to start and finish a game.

As a courtesy to the Recreation Department and the opposing team, if you know you are unable to field a team, please call and notify the office as soon as possible. This will allow us to cancel the umpire and notify the other team not to appear.

A forfeiting team has three options in regards to forfeits and umpire fees:

- 1. Contact the Parks and Recreation Department 48 hours or more in advance- No penalties for umpire or forfeit fees will be levied.
- 2. Contact the Parks and Recreation Department less than 48 hours in advance or forfeit at the field-Forfeiting team is responsible for paying umpire fees for both teams at the scheduled game time.
- 3. No call/no show- \$75 forfeit fee is kept by the Parks and Recreation Department and an additional \$75 must be put on file before participating in the next scheduled game.

Any team forfeiting two games in succession or three games during the season <u>may</u> be suspended from the league. In such cases, forfeits (wins) shall be awarded to the opposing teams in all previously played games and games remaining on the schedule. The schedule may then be revised.

If a rain-out occurs when you have called in advance, you will have the opportunity to make that game up. You will not be penalized for your courtesy.

#### FOUL BALL RULE

In the event the second strike is a foul ball, the kicker will be awarded one additional strike. A subsequent foul ball will result in an out, but the play will be live and runners may advance at their own risk on a caught foul ball.

#### **GRACE PERIOD**

Each game will have a ten-minute grace period, effective from the regularly scheduled game time. Time used will be subtracted from the total minutes allowed for game play. The umpire's ruling will be final.

Any team not ready to start after the grace period shall be subject to loss of the game by forfeiture. The grace period starts at the scheduled game time.

#### **GROUND RULES**

Pitching rubber will be at 50'. Pitching from any other distances is not permitted.

The base distance will be set at 70'.

Runners can be gotten out by throwing a ball to the base in which the player is running (if a force is in place), tagging the runner, or by hitting the runner with a thrown ball (below the shoulders). The runner's clothing is an extension of the body.

Runners that make contact with the ball (and not on a base that they are entitled to) will be called out regardless of whether it was thrown or not.

Runners hit above the shoulders when running in an upright position (not sliding or ducking) will be safe and awarded an additional base beyond the base they were approaching. A warning will be given to the player throwing the ball and a subsequent violation within the same game will result in an ejection.

Players throwing the ball at a runner in a manner that is deemed to be malicious and not in the spirit of the game will be ejected from the current game and will be subject to further suspension.

#### HOME TEAM

For position rounds, all tie breakers, and all play-off games, the higher seeded team will be home team.

#### **ILLEGAL PLAYER**

An illegal player is:

- Anyone who falsifies the roster in any way.
- Anyone who has been officially suspended or released from the league.
- Anyone who cannot produce identification or produces false identification.
- Anyone not on the team roster or with incomplete information by the cut-off date.

#### **INJURIES**

In the event that a player is injured (umpire's discretion) during the game, cannot return to action, and there are no players available to replace by using the re-entry rule, please see the extra hitter rule above.

#### In any circumstance, the injured player that is removed cannot return to the game at any point.

#### **INTERFERENCE BY CRASHING INTO DEFENSIVE PLAYERS AND OBSTRUCTION**

An offensive team may be charged with interference; while in the case of an infraction by the defensive team, it shall be obstruction.

It is the offensive player's responsibility to avoid contact with any defensive player when running the bases. When a base runner runs into a defensive player with or without the intent of dislodging the ball or preventing the defensive player from completing the play, he shall be called out. If it is a deliberate or flagrant act, the runner will be ejected from the game. This is a judgment call on the part of the official. If you slide, always go for the bag, never at the defensive player as that would also be interference and be subject to the above penalties. If you give yourself up, get out of the way or again you may be charged with interference.

Obstruction by the catcher may be called at <u>any time</u> from when the pitcher begins his/her delivery.

#### **KICKING**

All kicks must be made by foot or leg (below the knee), and must occur on or behind home plate. A pitched ball that is kicked prior to reaching home plate will result in an immediate dead ball and a strike is called. Bunting is allowed.

#### LEAGUE ADMINISTRATION

The Sterling Heights Parks and Recreation Department and its duly appointed representatives shall be responsible for the administration of this program.

#### LEAGUE RULES

ASA rules will be in effect for all games played. However, Sterling Heights league rules will take precedence over ASA when there is a deviation.

Normal defensive positions include: 2 males and 2 females in the outfield, 2 males and 2 females in the infield and 1 male and 1 female battery.

There is no minimum limit to the number of males that must be present to begin and end games.

The normal kicking order must alternate sexes. A team using more females may kick consecutive females.

## Outfielders must stand on the grass when the pitch is thrown. They can move onto the infield after the ball has been kicked.

On any walk to a male kicker, the kicker/runner will go immediately to second base (after touching first base). The next female player will kick as scheduled. No runner on base at this time will score unless forced in by this walk. **EXCEPTION:** With two outs, the female kicker has the option of taking first base or kicking as scheduled.

#### MANAGERS - CHANGE OF

Any change in manager ship of a team must be filed with the Parks and Recreation office the next business day, listing the new manager's name, address and telephone number.

#### MANAGERS' RESPONSIBILITIES

A manager is responsible for the conduct of his team and coaches before, during, and after a game.

Any manager not making a genuine and sincere effort to restrain an unruly player, who is subsequently ejected from the game, may also suffer ejection and a minimum one game suspension.

Managers are not required to keep a roster copy with them at all times. Official rosters will be kept in the Softball Office at L.W. Baumgartner Park. This roster will be accessible in the event of a roster challenge. A manager may be challenged at any time during a game, but not after a game. See rules on ineligible players.

Each individual team is required to keep a record of the team line-up and scores. Please be sure to check with the opposing team after each half inning to verify the score.

Managers shall be responsible for the eligibility of their players and for the validity of their contracts/rosters. An illegal contract/roster makes an illegal player. (See penalty for illegal player.)

In case of inquiry concerning any member or members of his/her team, the manager shall be liable for producing any evidence of records requested by Parks and Recreation.

<u>REMINDER</u> - Managers make sure your players are aware of the "NO DRINKING BEFORE / DURING GAME" rule and that your players observe this rule.

#### **MEETINGS**

Meetings shall be called at the discretion of the Parks and Recreation Department.

All teams must have a representative (manager or otherwise appointed) at the <u>Manager's Meeting</u> or any other scheduled meeting.

#### **MEMBERSHIP**

Any player who has attained the age of 18 years and/or has graduated from high school, on or before September 1st of the given season, and has a validated contract on file, is eligible for membership in the Sterling Heights Kickball League.

Teams and individual players may register and participate in any and all leagues sponsored by the Sterling Heights Parks and Recreation Department as long as all applicable rules are observed.

#### PARKING

USE ONLY DESIGNATED AREAS FOR PARKING. DO NOT PARK ON GRASS AREAS.

#### PARK REGULATIONS - L.W. BAUMGARTNER PARK

- 1. Please drive slowly and carefully in the parking lot. Watch for children.
- 2. No alcoholic beverages in immediate dugout area.
- 3. No drinking of alcoholic beverages before or during a game in which you are a participant.
- 4. Only the manager, players, coaches and scorekeepers are permitted in the dugout. No children!
- 5. Bikes must be walked through the park.
- 6. No dogs in park without being on a leash, six foot maximum. Dogs must not be unattended at any point.
- 7. Warm up in designated area only.

#### PENALTY FOR USE OF ILLEGAL PLAYERS

Any team using a suspended, ineligible, or released player shall be penalized in the following manner:

- A. The current game will be forfeited.
- B. Player will be suspended for three weeks.
- C. Manager may also be suspended.

#### PLAYERS' RESPONSIBILITIES

Players must have their driver's license/state ID with them at all times. Players cannot go to the car to get their wallet. If a player is challenged and cannot produce identification on the spot, the player is considered illegal (see penalty for illegal player).

Players must notify the Parks and Recreation Department and manager of any change in address.

Players must observe the Rules and Regulations of the City of Sterling Heights, Parks and Recreation Department and the League. Players must conduct themselves in a sportsmanlike manner.

Each player is responsible for his/her personal conduct and must refrain from drinking during his game, whether on the playing field or not.

Each player shall refrain from using language unsuitable for a public place. Continued usage will result in ejection and an additional suspension.

#### PLAYING FIELD

A designated line will be marked halfway between home plate and first & third bases respectively. In addition, a designated line will be marked for the catcher. The respective fielders at each position may not cross the designated line prior to the ball being kicked. An infraction will result in a dead ball and the kicker will be awarded a ball.

Please see attached diagram for field set-up and designated defense lines.

#### PLAYOFFS

Single Elimination Playoffs will begin at the end of the regular season and the Parks and Recreation Department will determine the schedule. Brackets will be determined according to regular season record.

#### **POSTPONEMENT OF GAMES**

The weather hotline is available to disseminate information on postponed games. No games are cancelled before 5:00 p.m. Beginning at 5:00 p.m., players may call 586-446-2693 to receive the latest status of that night's games. IN CASE OF POSTPONEMENT: MANAGER WILL NOT BE CALLED. The hotline will be updated as soon as weather conditions dictate.

Please do not call the main Parks and Recreation office. Please advise your players not to call the office. This only ties up the office lines of communication.

#### PROTESTS

If games are to be put under protest because of a misinterpretation of a rule or rules, these steps must be taken before Parks and Recreation will honor the protest. A judgment call cannot be protested. Roster challenges are not carried out under this rule.

- 1. The notification of intent to protest must be made immediately--before the next pitch.
- 2. The captain or manager of the protesting team must immediately notify the umpires and the opponent that the game is being continued under protest.
- 3. Both scorekeepers must be notified that the game is under protest so it can be appropriately marked on the score sheet.
- 4. Protest of any game shall be made in writing and filed with Parks and Recreation no later than two working days after the game in which the alleged violation occurred. The letter of protest must include the date, team playing, location, time, name of umpires, and all matters pertaining to the alleged violation, citing which rule or rules were allegedly violated.
- 5. Protest shall not be received or considered if they are based solely on a decision involving the accuracy of judgment on the part of the umpire.
- 6. There is a \$25.00 fee, which must be submitted with the formal protest. Fee will only be refunded if protest is upheld.
- 7. All protests shall be acted upon by the Parks and Recreation Director or duly appointed representative.

#### **RE-ENTRY RULE**

Any player may be substituted or replaced, and re-entered once, providing players occupy the same kicking positions whenever in the lineup.

The starting player and their substitute may not be in the lineup at the same time.

If a player re-enters the game a second time or a player re-enters the game in a position in the batting order other than their original starting or substitute position, it is considered an illegal re-entry and the player will be disqualified.

- ➔ This rule is separate from the extra kicker rule and players may not be used in both ways at the same time.
- ➔ Defensive positions may be changed, but the kicking order must remain the same. Any player used defensively must appear in the kicking order.
- → All defensive line-ups must conform to the male/female ratio.
- ➔ No defensive substitutions may be made during an inning unless it is on an emergency basis.

Upon observation of an illegal re-entry, the player who commits the offense will be expelled from the game.

#### **REGULATIONS FOR PITCHING**

The pivot foot must remain in contact with the pitcher's plate until the pitched ball leaves the hand. It is not necessary to step, but if a step is taken, it may be forward, or backward and simultaneous with the release of the ball.

The ball must be delivered at an acceptable speed and not be bouncing more than one foot from the ground.

The strike zone consists of the home plate and one foot to either side of the plate.

The pitcher must stay within the pitching circle until the ball is kicked.

#### **REPLACING PLAYERS** - Injured or Armed Forces

In the event a player is lost to a team at any time during the season because of a serious injury or sickness, said team shall be allowed to replace the injured or sick player. The players shall go on a voluntary retired list and shall not be eligible to play with any team in the program for the remainder of the season.

A doctor's certificate certifying that the player has suffered a serious injury or sickness may be required before a player replacing the injured or sick player can be used. Dr.'s Certificate and new player's contract may be turned in the same day the new player is to play rather than the day before. This player is eligible for the playoffs

Any team losing a player to the Armed Forces shall be allowed to replace this player at any time. Only a player who has not played in the program during the present season may replace the vacated player's roster spot. This player is eligible for all playoffs.

#### **ROSTERS**

No player shall appear in the line-up of any team in the League unless his/her name is legally affixed to a completed and validated roster, which must be on file in the Parks and Recreation office. <u>Players can only be on one roster per night.</u>

#### **ROSTER CHALLENGES**

A player's eligibility may be challenged at any point before or during a game in progress. Roster challenges should be specific to a person, not the entire team. There is no financial penalty for a roster challenge.

Once a roster challenge is called, the player in question must produce identification on the spot (cannot go to the car). This will be checked against the official roster kept in the Softball Office at L.W. Baumgartner Park. In the event the player does not have picture ID they may produce an alternate ID (IE Debit/Credit Card etc..) and be asked a series of personal questions to the extent listed on the roster sheet to verify identity. the league manager, on-site coordinator and ASA certified umpire must review the information. Any player not able to fulfill this criteria or not on the roster is an ineligible/illegal player (please see penalties under use of illegal player).

#### RUN AHEAD RULE (FORMERLY MERCY RULE)

The Mercy Rule of 12 runs after five innings or 15 runs after 4 innings will be in effect for all Sterling Heights Parks and Recreation softball leagues.

Example: Home team is leading by 12 runs or more after 4 1/2 innings of play or any following inning----they would be the winner of the game. Visitors are leading by 12 or more runs after five or more complete innings have been played they would be the winner of the game. This rule will be in effect for all games including playoffs/championships.

#### **SCHEDULES**

In an effort to conclude a season in a timely manner, league games and/or makeup games shall be played on dates and times designated by Parks and Recreation and may deviate from the normal days played on.

#### STERLING HEIGHTS WEATHER POLICY DURING GAMES

Parks and Recreation outdoor activities will be suspended at any lighting sighting or sound of thunder. Participants will wait 15 minutes; if no lighting is sighted or heard then activity can resume. If more lighting is sighted or thunder is heard then site supervisor decide whether to extend the suspension or to cancel the activity. Tornado/severe thunderstorm siren, signals immediate cancellation of activity. If shelter is provided for all participants, they should be directed there immediately. If no shelter is available, participants should evacuate the area.

#### SHORT HANDED RULE

A game may begin or finish with 5 males and 4 females in the field. An out will be taken when the vacant position in the batting order appears. When and if another player arrives (of correct gender missing), that player must be inserted into the line-up at the ninth or tenth batting position (depending on vacant spot by alternating sexes).

#### **SUSPENSIONS**

Parks and Recreation or its appointed representatives will have the authority to suspend a player for infraction of rules which may or may not be in the jurisdiction of an official, and are noticed by the Department or its representatives. Such suspension will be in effect immediately. The penalty for players, coaches and managers will be a minimum one-game suspension. Any player removed by "ejection" will be suspended from their next scheduled game (or more depending upon the nature of the infraction). Penalties shall apply whether the offense occurs before, during or after a game. Further infractions may result in lengthier penalties. The player or players involved have the right to appeal the

suspension in writing. This appeal will then be read and a decision made at the earliest possible date. A current list of suspended players is on file at the Parks and Recreation office.

Suspensions will carry-over to the following season for any player that is suspended towards the end of the season and still has games to be served.

#### <u>TIES</u>

In the event two or more teams are tied for first place at the end of the season, a one game playoff will be held.

If the tie involves three teams, the team with the best win/loss record against the other two will draw a bye. The other two teams will play one game, with the winner of that game meeting the bye team for the championship. If none of the three teams has a clear-cut win/loss record advantage, the team with the least runs scored against, in the games among the three will draw a bye. If all points, etc. shall be equal, a random draw shall be held to determine the bye.

All other ties for placement/seeding will be determined by head-to-head record, or runs against during the head-to-head games.

#### TIME LIMIT

A complete game of kickball consists of 7 innings of play, or a 50-minute time limit, whichever comes first. No new inning will start after 50 minutes. Both managers and umpires shall make note of actual starting time.

Unavoidable delays (injury, equipment failure) shall not be counted toward time limit. Intentional delays are not reason for extra time. If teams are tied after seven innings or at the time limit, they will be allowed one additional inning to break the tie. If no winner is declared after the extra inning, the game will end as a tie for the standings.

In the event of inclement weather, a game will be considered complete after 5 innings of play, or 4 ½ if the home team is winning. This includes the playoffs and championship game.

#### **UMPIRES**

The Parks and Recreation Department will contract with the officials. They have complete authority over the playing area and the conduct of the game. All umpire fees are the responsibility of the teams participating. In all leagues, one umpire will be assigned to all games. The City will not pay any umpire fees. Umpires shall be required to:

- A. Start game on time.
- B. Keep players hustling and game moving.
- C. Acquaint managers with ground rules and/or any other unique rules.
- D. Enforce rules and regulations governing the game.
- E. Warn players, managers and spectators who violate the rules and eject them from the game and/or facilities, if necessary.

## Umpires are scheduled by an outside association, not by the Sterling Heights Recreation Department.

STERLING HEIGHTS PARKS AND RECREATION ALSO RESERVES THE RIGHT TO MAKE DECISIONS THAT ARE DEEMED TO BE IN THE BEST INTEREST OF THE LEAGUE AND PROGRAM.
